



2023 SUMMARY ANNUAL REPORTS

Caltech Base Retirement Plan

This is a summary of the annual report for Caltech Base Retirement Plan, EIN 95-1643307, Plan No. 002, for period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$221,399,976. These expenses included \$542,976 in administrative expenses, \$220,729,348 in benefits paid to participants and beneficiaries, and \$127,652 in other expenses. A total of 22,250 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$4,792,181,822 as of December 31, 2023, compared to \$4,200,375,781 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$591,806,041. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$813,206,017, including employer contributions of \$149,595,542, employee contributions of \$12,985,327, other contributions of \$2,395,463, earnings from investments of \$645,100,517, and other income of \$3,129,168.

Caltech Voluntary Retirement Plan

This is a summary of the annual report for Caltech Voluntary Retirement Plan, EIN 95-1643307, Plan No. 005, for period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$78,090,412. These expenses included \$206,412 in administrative expenses, \$77,841,258 in benefits paid to participants and beneficiaries, and \$42,742 in other expenses. A total of 11,725 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$2,033,100,660 as of December 31, 2023, compared to \$1,667,111,588 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$365,989,072. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$444,079,484, including employee contributions of \$113,558,552, other contributions of \$60,941,442, earnings from investments of \$262,869,074, and other income of \$6,710,416.

Consolidated Welfare Plan of the California Institute of Technology

This is a summary of the annual report of the Consolidated Welfare Plan of the California Institute of Technology, Employer Identification Number 95-1643307, Plan Number 601 (the "Plan"), for plan year January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Uninsured Component plans (a "Component" or the "Components) of the Plan

The Plan sponsor, California Institute of Technology, to the extent required by applicable law and the terms of the Plan and applicable Component, has committed to pay from its general assets covered claims incurred under the terms of such Component. The uninsured Components consist of the Plan Sponsor's (i) health flexible spending account plan, (ii) certain self-insured dental benefits, and (iii) self-insured preferred provider benefits. Nothing in this paragraph shall make the Plan Sponsor liable for any claim for which the Plan Sponsor is not liable under the terms of the Plan or applicable Component, or under applicable law.

Insurance Information

The plan has contracts with Safeguard Health Plans, Inc., A California Corporation, Vision Service Plan, Kaiser Foundation Health Plan of Washington, Kaiser Foundation Health Plan of the Mid-Atlantic States, Inc., Zurich American Insurance Company, Hartford Life and Accident, Anthem Blue Cross, and Kaiser Foundation Health Plan, Inc. to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Business Travel Accident claims incurred under the terms of the plan. The total amount of premium paid for these contracts for the plan year ending December 31, 2023 was \$72,998,166.

Because the Anthem Blue Cross HMO plan is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2023, the premiums paid under such "experience-rated" contract was \$20,703,461 and the total of all benefit claims paid under these contracts during the plan year was \$17,915,203.
